I have reviewed your memorandum to me of June 4, 2004. As we have already discussed, the next logical step is for the Attorney General to complete the relevant legal analysis now in preparation. Once this work is completed and you have returned from your current travel, I can convene a Principals Committee meeting on this subject. In the interim, I will contact Attorney General Ashcroft and underscore the priority we attach to completing expeditiously the Department of Justice's legal analysis. I also encourage you to carry through on your expressed intention of talking to the Attorney General directly on this subject before any Principals Committee meeting.
